In the coming year, and going forward, a key focus of the board will be to maintain the financial security of CPS while working to raise the profile of our society. From my perspective this financial security is important so that we can continue to hold our scientific meetings, offer our students some financial incentives for attending these meetings, and continue to promote the

need for research in plant pathology. Those of you who have been CPS members since before we moved the publication of the Canadian Journal of Plant Pathology to Taylor and Francis will remember trying financial times for CPS. These changed when we altered the charges for publication of CJPP and moved to a new publisher. So, one of the key items that the board will need to work on is renegotiating the contract for the publication of our society journal. In this context the board will be considering multiple publishers and the possibility of converting the CJPP to an all-online format. Drivers for this new format consideration are the need to continue to increase the impact factor of the journal, to attract new authors, and to meet the expanding global requirement for open access. There may be other ways to do this, but one option is to push all publications to open access with the goal of reducing the per-manuscript open access publication costs for members. Look for an email survey asking about this and other possibilities. Perhaps President Lone

Buchwaldt will make mention of this in future presidential commentaries.

On another topic, one positive that has come of the pandemic has been the renewed interest in science and what it can do for society. I think we can use this to

expand interest in plant pathology.

Investigating plant diseases and how to combat them, or to cope with their destruction, is

critical for the maintenance of food security. The work done by CPS members past, and present has substantially contributed to the sustainability of crop agriculture in Canada and thus global food security. It is important to remember this as researchers in this area and to consider how your research can aid in crop production and protection. Personally, I will look to the increased interest in science, lessons learned from the pandemic, and from plant pathology to inspire my teaching and research going forward.

Les motivations qui justifient ce nouveau format sont le besoin d'accroître le facteur d'impact de la Revue, d'attirer de nouveaux auteurs et d'acquiescer à la demande mondiale croissante du libre accès. Il peut y avoir d'autres façons d'atteindre ce but, mais une solution est de favoriser la publication en libre accès de tous les articles afin de réduire les coûts de publication par manuscrit, et ce, pour tous les membres. Surveillez l'arrivée d'un courriel contenant un sondage sur ce sujet et d'autres possibilités. Le président, Lone Buchwaldt, en parlera sans doute dans son commentaire présidentiel.

- 6 President's Report (Barry Saville): great to work with CPS Board, frustrating to deal with

COVID, are in a good position going forward, will meet in person soon, presented idea to host the 2028 ICPP conference in Canada (Winnipeg). Presented brief talk from Winnipeg Tourism to explain why Winnipeg for host city. Many companies headquartered in Winnipeg, can get sponsor funding. Several government agencies and science institutions. Winnipeg is central to North America, easy to get to. Large convention centre, newly renovated. Cheaper accessible hotels. World class attractions, airport close. Special Event Tourism Fund (\$101K) available. The other thing of note is the desire to increase Impact Factor of the CJPP journal and the possibility to go Open Access. Lots of discussion in CPS Board meetings. Consulted Editorial Board on this and decision was to wait until end of current contract. Will be putting out a survey to the membership to get their opinions. OA vs. hybrid model. Will be putting this out soon.

7 Treasurer's Report and Financial Statement (Ken Conn)

- 7.1 Financial Statement- was presented to members by sharing screen; auditors said everything was OK, will be sending report to members. Page 4 shows funds, new Greg Boland Invited Speaker fund, Donations high in 2020, \$81K from Duncan estate. Gave background of Duncan estate/will. John Yorkton. More \$ to come later, funds are unrestricted. New John Yorkton Graduate Student Scholarship (JYGSS) was created using \$93K. Total balance was \$899,671 in 2020. Page 3 shows total assets (\$929K). Also have \$2-3K from CPS members.

8 Report of the Financial Advisory Committee (Dilantha Fernando): the FAC met on June 9, healthy finances now, donations and change to Taylor & Francis publisher big impact, several motions made at meeting. Have lots of money, challenged CPS members to provide possible ways to spend the funds and send to Board. Sara Stricker: travel award to send students to ICPP. FAC report will be published in June 2021 CPS Newsletter.

9 Report of the Historical Resources Committee (Barry) Published in CPS June Newsletter.

10 Update on CJPP and T&F (Stephen Strelkov): gave update on CJPP, Zamir Punja stepped down in June 2019 (19 yr service), New editorial board structure and board appointed in 2019. Added Associate Editors. Senior editors now doing 1st desk review before assigning to AE. Gave metrics of journal, speed of acceptance, 33% acceptance rate, 2019 IF was up to 1.236, 2020 CiteScore was 2.9, 106/347 for Agronomy/Crop Sci. and 148/445 for Plant Science. Increasing to 6 issues in 2021, Special Issue on Rust Diseases. Also Twitter account (@CJPP_CPS). New initiatives: Open Access. Presently have hybrid model, author can pay for OA. Concerns on financial impact to CPS if move to full OA. CJPP Journal Editorial Board recommended to keep CJPP model as is until current contract with T&F expires in 2023. Use revenue from page charges to pay for 6 OA articles per year. Re-assess move to OA when discussing new contract. Going forward: continue to build momentum and improve journal, increase IF, invited reviews, Special Issues, ideas from membership, need to establish new agreement with publisher, potential for OA,

submissions welcome from colleagues worldwide. Gave list of Senior and AE, Acknowledged Zamir, Michael Holtz, Ken Conn, Hennie Thomson and Sara Griffiths at T&F, and CPS. Question on how the SE are selected. Steve: for AE, often get input from the SE. Likely the AE would move up to the SE. Dilantha: most of change happened before Steve appointed. People can put up their name for Editors to Steve. Question on terms (Steve: 3 years). Reem: hard to find reviewers due to COVID. Dilantha: not just COVID factor. Zhongwei Zhou: no grants/awards for Post-Docs, funds for them would be nice. Risha Burlakoti: JEB board meetings in future? Steve: have had meetings with SE. Planning to have another one with whole editorial board after we get the 2020 IF from Hennie. Tracking reviewers: time-consuming. Maybe T&F can help. Currently getting 400 submissions per year.

Committee Reports

Historical Resources Committee Report

The Historical Resources Committee continues to collect materials that are of historical significance to the Canadian Phytopathological Society, Canadian science and the Canadian public. These include CPS Board agenda, minutes, correspondence, proceedings of Society meetings, photographs of Society activities and members etc.

Currently, these are being preserved for posterity in two ways: 1) in facilities under management of Archives Canada in Ottawa; and 2) on-line electronically in a secure server in the CPS website. In the late 1980s, Ottawa-based AAFC pathologist Lloyd Seaman and I undertook the task of dealing with file cabinets full of CPS-related files amassed by Art Skolko, a retired Agriculture Canada scientist who had since passed away. We established an account with Archives Canada and transferred the materials to them. Since that time, I have collected materials from members as they retire and arranged for their periodic transfer to Archives Canada. This past year, I have transferred 7 boxes of materials to Archives Canada.

During the past 3-4 years, I have worked with our webmaster Michael Holtz, to store materials of archival importance to CPS, on-line in a secure format that is routinely backed-up. This system has been set up and I have uploaded CPS files dating from 1999-2021. I routinely receive current files from the CPS Secretary for Archiving. The mission of the Historical Resources Committee is to upload all important information, including photographs, to our website and routinely archive an electronic copy of the Website with Archives Canada for permanent storage.

The CPS remains a vibrant, inclusive scientific Society with a story to tell! In this vein, we continue to receive any materials of historical relevance to CPS, whether in the 'old-school' paper format or in electronic format. This includes those from past-Presidents and Board members! Please forward your materials to denisandregaudet@gmail.com.

CPS Local Arrangements Committee Report

The LAC this year is organizing a virtual meeting due to the pandemic restrictions. A Tri-Society Conference has been organized as a virtual conference with the Canadian Phytopathological Society (CPS), the Canadian Society of Agronomy (CSA) and the Canadian Society for Horticultural Science (CSHS) to bring together researchers in plant science. The theme of the meeting is "Innovation in Plant Science and Agricultural Resilience". The conference will be held on July 5-9, 2021 with two workshops the following. There will be scientific programming daily 11 AM – 5 PM EST (8 AM – 2 PM PST). Registration page and information are at <https://trisocieties2021.ca>.

Scientific sessions will consist of pre-recorded videos followed by an interactive discussion with the presenters. Videos from the meeting will be available on demand for registrants from July 9 to July 23. We are developing the scientific program and will have sessions on: Genetics, Biotechnology, and Breeding; Genomic Applications for Crop Improvement; Plant, Soil Health and the microbiome; Climate Change; Innovations in Agronomy; Innovations for Pre- and Post-Harvest Quality. We will also have presentation from keynote speakers and societies awardees.

Virtual meeting rooms will be available for any group sizes each day, and is a good opportunity for professionals working in plant sciences to discuss the latest research, learn from peers and expand their knowledge. These networking opportunities can move research forward and enhance participants' careers. We also will have student competition session with both oral and poster sessions, with flash presentations for the posters.

Student activities are planned including advice on career progression, fun games and contests. On July 12 and 13 we will have workshops:

Workshop #1: Equity, diversity and inclusion in research environments

Workshop #2: Tips for successful publication in peer-reviewed scientific journals.

More workshops will also be announced soon to happen throughout the remainder of 2021. To date we have received approximately 170 abstracts and more than 200 people have already registered for the meeting. Please note registration is open until July 2nd. 2020-2021 Canadian Plant Disease Survey Report

In 2020, 59 papers were published in the 100th edition of Canadian Plant Disease Survey (CPDS), comprising 30 Cereal, 15 Oilseed, eight Diagnostic Lab, four Fruit, Nut, Berry and Ornamental, and two Vegetable reports. A foreword to the 2020 edition entitled, "100 Years of the CPDS", by J. Elmhirst with editorial help from K. Turkington, was included to mark this historic milestone. In January 2021, the Canadian Agriculture Library completed a digitization project that included volumes 1-8 of "Survey of the prevalence of plant diseases in the Dominion of Canada" and shared them with us to post on the CPS website.

The 2019 volume was not published until August, so we had hoped to publish earlier in 2020. Unfortunately, publication of Vol. 100 was delayed in 2020, in part due to SARS-CoV-2. The 2020 issue was published online on September 30, as a supplement to Vol. 42 of the CJPP, but was incorrectly titled "2019". The title was corrected on October 27, 2020 and a link to the survey posted on the CPS website.

In 2020-21, 53 papers have been submitted to Volume 101 of the CPDS, comprising 22 Cereal, 16 Oilseed, nine Diagnostic Lab, three Vegetable and two Forestry reports, plus the first survey of crop diseases in Yukon Territory by Ron Howard and Kristine Ferris. This issue is expected to be published online in late summer/early fall of 2021.

Starting with Volume 99 in 2019, the CPS Board of Directors contracted with Taylor & Francis to publish the survey as an annual, online supplement to the Canadian Journal of Plant Pathology (CJPP). This has been successful in raising the profile of the Survey. I am pleased to report that, as of mid-November 2020, the 2019 CPDS had been accessed more than 3000 times and currently, as of the end of May 2021, the 2020 issue has been accessed

almost 2000 times.

Editorial Board Updates:

Thank you to Vippen Joshi who replaced Marilyn Dykstra as Section Editor for Diagnostic Laboratories starting with Volume 101, in 2020.

Thank you to Kelly Turkington, who has stepped down as Section Editor for Cereals in 2021 after several years and will be replaced this fall by Reem Aboukhaddour for Volume 102. Many thanks to Reem for volunteering to take over our largest section, and to Kelly for serving as Assistant National Editor for the last two years, also.

Many thanks to Debra McLaren, also, who has stepped down as Oilseed and Specialty Crop Editor in 2021, following her retirement from AAFC, and thank you to Syama Chatterton, who has offered to take over this section in the fall for Volume 102.

Finally, I wish to thank to all of our authors, section editors, compiler Deidre Wasilyw and the hard-working technical editors at Taylor and Francis, who help to ensure that the CPDS remains an important and relevant publication for plant disease in Canada, as we enter our second century.

I followed my passion for science in university, studying molecular biology at the University of Regina, convinced that this was the only path to science in my life. All of this changed in the second summer of my undergraduate degree. I started working within agriculture as a surveying summer student. I dove head first into a world of plant disease and insects. I travelled rural Saskatchewan, seeing the beautiful province and speaking to producers. I learned about crops first hand, the pathogens and pests that plague crops, and the wonderful community of agriculture. I continued to learn about pathology and agriculture throughout my remaining summers as an undergraduate; my thirst for knowledge never satisfied. I decided to pursue higher education in plant pathology in order to keep learning, stay true to my passion for science, and stay within the wonderful agriculture field.

I'm now pursuing a Master's of Science degree in Plant Sciences at the University of Saskatchewan, working in the Cereals and Flax Pathology group. My project focuses on expanding Fusarium head blight breeding resources through finding possible sources of resistance and validating possible germplasm screening techniques. Fusarium head blight is a devastating disease in cereals, and sources of resistance are continually being searched for. By completing my project, I hope to aid in obtaining meaningful control of Fusarium head blight and thereby help producers reach their optimal yields and grades.
